COVID-19 is a highly contagious respiratory disease that spreads easily from person to person. It lives on some surfaces for days. It can be picked up from touch or contaminated surfaces and may lead to serious illness or death.

For some, the symptoms are a fever of 100.4 F, a cough, sneezing and/or a shortness of breath. There are reported cases where some people have lost their sense of taste and smell. More concerning, some people are asymptomatic – they have none of the symptoms – but they are carriers of COVID-19. At this point, there is no cure - no vaccine.

I am strongly suggesting that we pray as often as we can for the passing of this pandemic. Wash your hands frequently, cough or sneeze into your elbow, take vitamins to boost your immune systems, and <u>STAY HOME</u> unless it is an emergency. Pay close attention to your body. Call your doctor or 311 if you have any questions. Let's stay calm and wait. This too shall pass.

Legislative Priorities

Senate Bill 606





(HB 917) - Criminal Law-Hate Crimes - Basis - (2nd Lt. Richard Collins, III's Law):

In 2017, 2nd Lt. Richard Collins III was murdered while visiting the University of Maryland. He was targeted due to the color of his skin. This bill will address this issue of by clarifying that hate can be one of the factors for crime but does not have to be the sole factor to secure a conviction under the hate crime statute.

Senate Bill 641

(HB 1097) - Maryland Wage and Hour Law and Maryland Wage and Collection Law (Maryland Wage Protection Act):

This bill ensures that workers who work an honest day's work are given their fair pay. It seeks to close loopholes in Maryland's wage law by protecting employees from retaliation; promoting transparency by requiring that paystubs to contain information how, and prohibit employers from misclassifying employees as independent contractors.

Senate Bill 833

(HB 1527) - Adult Protective Services - Vulnerable Adults Registry - Investigation and Records of Abuse and Neglect and Workgroup Study:

In an effort to protect some of our most vulnerable citizens, this bill seeks to create a statewide elder abuse registry. The registry woul dbe similar to the existing confidential and centralized statewide child abuse and neglect database.

Senate Bill 1024

(HB 938) - Home Energy Assistance - Critical Medical Needs Program - Power to the People Pilot Program:

This bill seeks to expand access to the Critical Medical Needs Program for individuals all over the State of Maryland who are critically ill and seek assistance from energy and efficiency programs.

Senate Bill 952

Health Insurance - Requirements for Establishing Step Therapy Protocol and Requesting Exceptions This bill expands patient access by ensuring appropriate, common sense guardrails are applied to step therapy to help patients receive the most effective treatments as quickly as possible.

PG 410-20

Prince George's County - County Income Tax Credit - Credit for Primary and Specialty Health Care Providers:

Capitol Heights has been identified as a health enterprise zone that lacks access to primary care services & resources for health services. This bill aims to allow the Prince George's County Council to authorize a primary or specialty health care provider to claim a tax credit if they reside in Prince George's County and are employed by a medical practice within the 20743 area.

Stimulus Bill FAQ

What is the stimulus bill?

Lawmakers passed a \$2 trillion bill to address recent economic struggles. The bill will send money directly to individuals based on specific income criteria based on 2019 or 2018 tax return information.

Who will receive money and how much?

- Individuals who made less than \$75,000 will receive \$1,200
- Married couples who made less than \$150,000 will receive \$2,400
- Parents would see an additional \$500 for each child under age 17

If you receive social security...

- If you do not exceed listed income limits listed above, you are eligible
- If you don't make enough to file a tax return, you will receive a check as long as you receive an SSA-1099 form
- The check will be delivered the same way you usually get Social Security payments
- If you receive disability checks from Social Security, you are eligible for the special payment

- (4) No one will be calling you asking for banking information to deposit your stimulus check.

Extensions and Utility Assistance

- The Maryland Department of Assessments and Taxation announced that the 2020 deadline to submit Annual Reports and Personal Property Tax Returns will be automatically extended to July 15
- Pepco and BGE have announced they are "suspending service disconnections and waiving new late payment fees through at least May 1.
- Washington Gas will be suspending disconnections and waiving late fees until the end of the crisis.

- WSSC Water have also announced that they will be suspending all water service shutoffs for those facing financial difficulties.

Price Gouging Prohibited

Maryland has announced an executive order that prohibited price gouging on the following items:

- Food/beverages
- Cleaning products
- Medicine
- Fuel
- Water
- Delivery services

2020 Maryland Census

What is it?

The census counts each living person in the US. It serves as the leading source of quality data about the nation's people and economy.

How does the census work?

Data is collected through various types of surveys. Federal funds are dispersed based on the number of people reported living in each state/county/community.

Why does the census matter?

- Determines how services and critical programs are funded
- Impacts legislative districts and representation in Congress
- Affect school construction, economic development, and emergency planning
